ADDRESS INFORMATION SHEET

Information sheet on Brunswick County's Property Address Program

ADDRESS NUMBER DISPLAY:

1. Owners of every improved lot or parcel of land shall permanently attach and display the address number assigned to that lot or parcel of land.
2. Number specifications:
 - A. All numbers must be displayed as numerals, not words.
 - B. If posted within ten (10) feet of the ground level, each number must be a minimum of three (3) inches in heights; if posted over ten (10) feet above ground level, each number must be a minimum of four (4) inches in height.
 - C. All numbers must be of a contrasting color to the color of the surface where the numbers are posted.
 - D. The numbers shall be posted on the side of the building facing the street shown in the official address.
 - E. Where the building is located more than sixty (60) feet from the edge of improved portion of the road, the numbers must also be displayed as follows:
 1. on a freestanding sign located not over twenty-five feet from the edge of the road, or
 2. on a mailbox located according to U.S. Postal Service regulations, at the edge of the road.
 - F. If you use a roadside mailbox that is not located on the official address road, but on another road, please display your official address number and road name on your mailbox.
 - G. Numbers shall be posted where they can be clearly seen from the road, and are not partially or totally obstructed by trees, shrubs, or other items.
 - H. House numbers should be displayed as soon as possible, for your benefit.

OTHER INFORMATION:

1. Suggestions for notification of official address: -driver's license – checking accounts
2. If the official address will also be your mailing address you should notify:
-postal service – power/phone company – store accounts – family member's – municipal/county tax departments
3. If you have children, educate them on their proper address.
4. Display your official address next to your telephone(s).
